9:30 am I reported to Judge Jerry that the sign posting the 100 foot rule was too close to building out front. We went outside and Judge Jerry said, "that's where I was told to put it. In a multi-use building the 100 feet is from the entrance to the room." I informed him that was not my understanding.

10:15 am- I reported to the 33rd St. Clerk's Office and signed in as Watcher for the Issue Committee *No to 52*. I asked Mary Beth who was Iola Freeland? Mary Beth looked around the Clerk's office area and said Iola was not there and asked me why. I told her I noticed most of the UOCAVA emails had been forwarded from Freeland.

I asked Mary Beth if a Supervising Judge was available and assigned for me to communicate with. Mary Beth said for me to address questions to her a s Lead Judge, although acknowledged that questions and complaints are never answered.

10:25 am Signature Verification Room - Asked about large yellow envelopes and informed they are email ballots. Worker then asked Mary Beth, "Are they supposed to be here with these ballots? Referencing me.

I requested access to other Signature verification room and denied.

10:45am I left the Signature verification room and witnessed two male Workers leaving the opening and sorting area with three clear plastic envelopes with what appeared to be completed ballots. They exited the double light wood doors and down back stairway. And saw going down stairway. One was husky, 6' tall and bald and returned five minutes later with one clear envelope of what appeared to be blank ballots. Both males I identified and took pictures of the next day working outside. I brought the incident to the attention of Mary Beth and she gave me no explanation.

12:30pm at CU University Club Early Voting as Watcher on behalf of the Issue Committee *No to 52*.

12:45pm Male elector presents. Judge reports "you received an absentee ballot to 2600 12th Ave. Elector says he does not live there anymore. Elector was then able to fill out form and vote early.

1:00 pm Poll Watcher Jim Eyster for the Republican Party arrives and I discuss situations with him. At end of day he reports that 491 ballots were cast on 10-31-2012 at the CU University Club Early Voting. Jim's other report item was that the Judge greeting the electors did not appear to be informing them not to use cell phones and not to wave around printed material from political parties.

3:00 pm I reported to County Clerk office and sign in as Watcher for Issue Committee Proponent of 52 Meetings. While waiting for escort, male elector Berlein (last Name) of 706 Mohawk Drive, Boulder reports to Clerk's reception desk. Said he signed up for but did not receive mail-in ballot. Told to go downstairs and vote today or wait for mail-in ballot.

Another elector with the same problem came in -Sarah Cameron - requested mailin but coming to vote.

Reported that it would be helpful for the Workers and Judges to wear badge with name or number and color coded for easily recognition.

Reported to signature verification. I feel the following ballots should be checked by bi-partisan team:
