

Signed Certificate for Angela Zimmerer as Watcher for the Issue Committee to Pay City Council Members for 52 Meetings. Also signed Certificate for Kathryn Lehr as Watcher for the Issue committee No to 52. All Watchers were assigned to Mary Beth Schuh.

I observed in the main signature verification room. At 9:30 am at WorkStation #1 brought up on the screen was four ballots with blank signatures. I do not know the status of these ballots.

3:15 pm Ballot Resolution Room: The shades were closed to the right side of the room where the Tally Computer sits. One tall black haired Election Worker who I had not previously witnessed had set himself up in the corner and placed the Tally computer on a table diagonally so the screen was not visible to any person except this one Worker.

I requested the shades be opened now that one person was at the Tally machine and that I be able to enter the roon and witness the Worker's activities.

In the Open and Sort area, at one table two Workers were transposing the UOCAVA fax and email ballots by hand onto regular ballots.

AS MENTIONED NUMEROUS TIMES, IN EVERY ELECTION PROCESS LOCATION, IT IS IMPERATIVE FOR ELECTION WORKERS TO WEAR BADGES WITH THEIR IDENTITY CLEARLY VISIBLE BY NAME OR NUMBER <u>AND</u> COLOR-CODED FOR PARTY AFFILIATION.
